### **WHO IS COVERED BY THE WARRANTY**

### **WHAT IS COVERED BY THE WARRANTY**

IPT Sink Company warranties this product against defects due to material or craftsmanship error during the warranty period. IPT Sink Company will provide replacement parts at no charge, or at its option, replace any product or part of the product that is deemed defective, under normal installation, use, service and maintenance. If IPT Sink Company is unable to provide a replacement and repair is not practical or cannot be made in a timely fashion, IPT Sink Company reserves the right to refund the purchase price in exchange for the return of the product.

- Sink Grids, Strainers, accessories such as wood chopping boards are specifically excluded from this warranty. (Faucets hoses are limited to one year)
- Commercial use will automatically void this warranty.

IPT Sink Company reserves the right to inspect any sink reported to be defective prior to any replacement of the sink.

All decisions are final. Replacement cost EXCLUDES transportation and any labor costs for the removal or reinstallation.
